## **Background**

- Livestock industry is one of the drivers of the economy
  - Trade, food, Source wealth, Source of raw materials, Employment, etc
- Livestock industry a player in policy & politics
- Disease outbreaks poses a major threat to livestock industry (economy)
- Explore scientific ways of minimising disruption to trade in the face of an outbreak
- Commodity based trade (CBT) is an option

#### Older version of the Code

- Challenge where there are buffalo within vicinity of susceptible animals – e.g. cattle
- Older version of the Code: articles 8.8.12 and 8.8.22:
- ".....were kept for the past 30 days in an establishment, and that FMD has not occurred within a 10 kilometre radius of the *establishment* during that period"

### **Revised Version of the Code**

- After input from CVOs in Southern Africa Phakalane Declaration (the process described in earlier presentation)
- Revised Articles 8.8.12 and 8.8.22:
- ".....were kept for the past 30 days in an establishment, and that FMD has not occurred within a 10 kilometre radius of the establishment during that period, or the establishment is a quarantine station;"

Quarantine Station - means an establishment under the control of the <u>Veterinary Authority</u> where <u>animals</u> are maintained in isolation with no direct or indirect contact with other <u>animals</u>, to ensure that there is no transmission of specified pathogen(s) outside the establishment while the <u>animals</u> are undergoing observation for a specified length of time and, if appropriate, testing and treatment.

## **Revised Version of the Code**

- Quarantine not a new concept in southern Africa
- Meaning animals in the quarantine are safe and can be trade without spreading the disease
- Imagine quarantines strategically located in Ngamiland

## Other OIE Tools facilitating CBT

- Protection zones (buffer zone)
- Containment zone
- Transit through infected zones.

## Other consideration when implementing OIE Standards for CBT

- OIE standards provides for CBT
- Note the importance of a Control Program know what is going on in your country
- DVS is very important (credible & practical)
- Good application of CBT requires good knowledge of animal dynamics in the area (movements, risk factors, husbandry system, existing barriers, farmers, industry, etc..)
- Need for transparency and trust for trade
- reluctance from trading partners (regional & international)

# Other consideration when implementing OIE Standards for CBT

- Countries (DVS) must belief in CBT to convince trading partners; i.e.
  - practice CBT nationally before going to regional trading partner
  - practice CBT regionally before going to international trading partners
